

AYSO SECTION 1 EXTRA PROGRAM

AYSO EXTRA - Section 1 requires an initial application or an annual application from regions that wish to participate in the EXTRA program.

In evaluating a new or existing program the primary responsibility of an Area Director and Section Director is to confirm that the region is “healthy” and able to support the EXTRA program without placing the Standard Core program at risk.

New and returning regions are approved based on the following criteria:

- Does the region have all 7 required positions filled by different individuals and do they have the appropriate certification and training?
- Is the EXTRA Program Coordinator adequately trained?
- Are there an adequate number of age-level certified coaches?

Coaches shall have completed the AYSO training levels below:

9U/10U - 10U and U12 certification

11U/12U - 12U and Intermediate certification

13U/14U - Intermediate and Advanced certification

15U - Advanced with National Preferred certification

We multiply the number of teams in a division by 2, and compare to the number of coaches certified at each level.

- Are there an adequate number of certified referees and at the appropriate badge level?

Referees will be assigned to games in divisions for which they are certified based on certification badge level as follows:

9U/10U – Regional

11U/13U – Intermediate

14U/18U – Advanced or National

We multiply the number of teams in each division by 3 and divide by 2 (since there are two teams playing in a game) and compare to the number of referees certified (we only take into consideration highest certification)

- Is the region’s “plan” on coach selection, and player selection in keeping with Section EXTRA Guidelines?
